## Five generations of local family serve as firefighters for community

Five generations of a family have served as firefighters in the Village of Wappingers Falls and City of Beacon.

Four generations of the Lahey family have served a total 118 years, and counting, of active service in the City of Beacon Fire Department. Two generations are still serving in that department.

### Dennis P. Lahey leaves legacy in Wappingers Falls

Serving the community in the fire service for the Lahey family began in Wappingers Falls. Dennis P. Lahey was an active member of the S.W. Johnson Engine Company #2 in Wappingers Falls. That was in 1910. He was also served as a constable for Wappingers Falls.

### Sons follow in father's footsteps

Dennis P. Lahey's sons, Hank Lahey and Joe Lahey, continued the family's giving back to the community when they became firefighters. Joe Lahey was elected to the Lewis Tompkins Hose Co. #1 and the City of Beacon Fire Department (BFD) as an active member in March of 1940. He was elected to Fire Police, 2nd Lieutenant, 1st Lieutenant and Captain. He was a Company Trustee for 20 years. He served 59 years, 1940 to 1999, to the company and BFD.

Hank Lahey was a 63-year member of the S.W. Johnson Engine Company #2.

### Firefighting tradition continues in Beacon

Dennis "Denny" J. Lahey, Hank's son, served 51 years as an active firefighter, from May 1960 to June 2011.

"I've always been interested [in the fire service] ever since I was a little kid," said Denny recently.

He recalled living across the street from the Johnson fire house in Wappingers Falls growing up. In the Village,

two doors down from where Denny lived, was the Academy Theater. Denny remembered that in 1937 there was a fire at the theater.

"We had to get out of the house and cross the street. We watched the fire burn," Denny remarked. He said he was 6 or 7 at the time of that fire.

When he was around 26 years old, Denny joined Tompkins Hose in Beacon.

When asked if he has ever been scared

on any calls, Denny replied he had "some close calls."

"A fire company is organized for the protection of life and property of the community it serves," said Denny.

Denny was elected to active membership in Lewis Tompkins Hose Co #1 and the City of Beacon in May 1960, he said. He held positions of: 2nd lieutenant, 1st

## Service remembers local veteran without known family

A funeral service was held for U.S. Marine veteran Luis Domingo Olivo-Paz on March 11. The 83-year-old had no known family, so Joseph Schuka, a funeral director with Libby Funeral Home, arranged local veterans and community members to honor the late veteran.

Olivo-Paz was a recent resident of the Montrose VA Hospital, according to his obituary. He was born in Puerto Rico. Schuka noted Olivo-Paz served during the Vietnam War.

"The reason we feel the importance of serving the veterans, especially when there's no next-of-kin, is that no one should ever have to be buried alone. As long as I am serving as a funeral professional, there will always be someone standing over that veteran offering respects, and honoring their life and service," said Schuka.

Rev. John Thawale, parochial vicar of St Joachim-St John the Evangelist Church, led the service. A letter

## Downstate Correctional Facility closed

Downstate Correctional Facility, a maximum-security facility in Fishkill, is closed.

The New York State Department of Corrections and Community Supervision (DOCCS) said in a statement last week, "Therefore on March 10, 2022, the close of business, the following facilities will officially close: Ogdensburg Correctional Facility, Moriah Shock Incarceration Correctional Facility, Willard Drug Treatment Campus, Southport Correctional Facility, Downstate Correctional Facility and Rochester Correctional Facility."

In the DOCCS statement, it was noted, "The Fiscal Year 2021-22 New York State budget that was voted on and approved by the Legislature authorized the Governor to close state prisons as the incarcerated population continues to decline and as a fiscally prudent and safe way to save taxpayer dollars."

Dutchess County Executive Marc Molinaro said in a statement to Southern Dutchess News, "We lament the unnecessary closure of the Downstate Correctional Facility – a move that will fracture the lives of hundreds of Dutchess County residents who have dutifully worked at the site for years, as well as their families – despite my repeated requests for Gov. Kathy Hochul to reconsider, pleas echoed by state and local leaders."

A union representative for this area did not respond to request for comment by deadline.

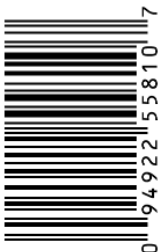
According to DOCCS, as of March 9, the total incarcerated population in state correctional facilities was 30,602. This represents both a total reduction in excess of 13,600 individuals since January 1, 2020, and the lowest total incarcerated population in New York State prisons since 1983. This is nearly a 58% decline in population since the Department's high of 72,773 in 1999, with New York leading the nation with the lowest imprisonment rate of any large state.

"The State's attempt at compassion for inmates has instead scattered these incarcerated individuals throughout the state, at facilities much farther away from their loved ones, and has left us with a deserted, blighted eyesore in southern Dutchess County," said Molinaro.

"New York State continues to be at the forefront of some of the

lieutenant, captain, fire warden (LTH), fire warden (LTH), chief of the BFD, 2nd assistant chief, 1st assistant chief, chief of the department and trustee of the LTH. Denny said he was appointed the first rescue captain of the BFD and first safety officer of the BFD. Denny has served on numerous committees, including the committee to revise the current Rules and Regulations to bring them up to date from 2001 to the present. He also serves as the Tompkins Hose Co. company historian.

### Going on calls with dad

Denny's son, Dennis P. Lahey, is a current active member of the BFD.

"Dennis and I went to the firehouse all the time," said Denny recalling when his son was growing up in Beacon.

"I went to a lot of fires with him, even before I was old enough to join," said

Dennis recently.

In January of 1975, Dennis was elected in to the Lewis Tompkins Hose Co. 1 and the BFD as an active member. Since that time, he has held the positions of: 2nd lieutenant, 1st lieutenant (twice), captain (twice), 2nd assistant chief, 1st assistant chief, chief. He is in his 47th year of service to the city of Beacon.

With almost five decades serving as a firefighter, Dennis remarked, "A lot of people are not going to do this for free anymore. There are not monetary rewards but the reward is helping people - which is just as good as monetary."

In 2017, Dennis was awarded for his first responders service by the Beacon Elks, just as his father was in 2009.

### First female firefighter in the family serves the city

Kari Lahey, daughter of Dennis and granddaughter of Denny, signed up to

serve in the BFD when she was 16 in 2003. Kari was the first female junior firefighter in the Lewis Tompkins Hose in the BFD.

"I'm proud of her," Dennis said of his daughter. "I'm at most of the calls she is at. Of course, you're always concerned that nothing goes wrong."

Denny said being a firefighter is what his granddaughter loves.

Kari was elected as the first female member of the Tompkins Hose Co. when she was 18 years old as a senior firefighter. She has been elected to: 2nd lieutenant, 1st lieutenant. She went on the exempt rolls in 2010. In 2020, Kari was appointed by the Beacon City Council as the first career female firefighter in the city.

Dennis said anyone who is new to the city, or someone who has lived in Beacon for a long time, should look into how the fire company operates.

nation's most progressive criminal justice reforms by spearheading smart and fair policies that have resulted in a drastic decline in the incarcerated population," stated DOCCS.

DOCCS carefully reviewed the operations at its 50 correctional facilities for possible closure. "This review was based on a variety of factors, including physical infrastructure, program offerings, facility security level, specialized medical and mental health services, proximity of other facilities in the area to minimize the impact to staff, potential re-use options and areas of the state where prior closures have occurred in order to minimize the impact to communities. Consideration of the impact of the recently enacted HALT and Less Is More legislation was also weighed," according to DOCCS.

DOCCS stated it is working closely with the various bargaining units to provide staff with opportunities for priority placement via voluntary transfers, as well as priority employment at other facilities or other state agencies as a result of the formal Civil Service process that is followed with the closure of a correctional facility. This process is done gradually. DOCCS does not anticipate any layoffs due to these closures.

DOCCS will also work cooperatively with the Office of General Services and Empire State Development to facilitate the re-use of the closed facilities. Upon closure, DOCCS will begin the decommission process in order to protect the State assets for potential re-use, stated DOCCS.

Molinaro noted, "With the site now cast away by New York State, Dutchess County would advocate for its highest and best use, but defers to the Town of Fishkill and its residents to determine how they'd like to see the property repurposed. As the County has successfully done with the repurposing of other large, abandoned or underutilize parcels, our team stands ready to provide support and guidance to the town and the state in any analysis, investor attraction and subsequent permitting process to ensure the best outcome for our community."

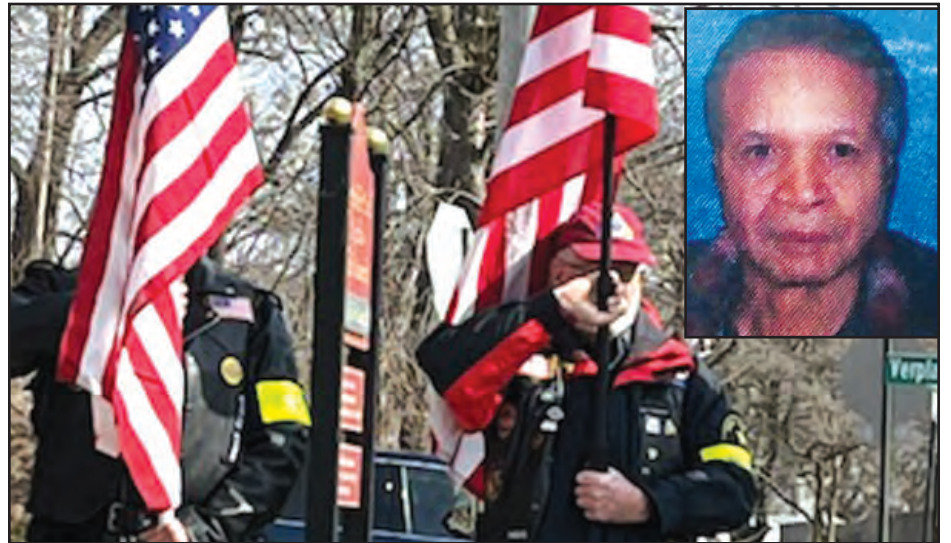

“Even if it is not a veteran and just an ordinary individual who for whatever reason has no family, I will be there with my staff to utter a kind word of farewell, ‘Go in peace, and be at rest.’ Every life is worth honoring,” stated Schuka.

Honoring the late veteran were local

Marines from the Carmen Ramputi Detachment 861 of Beacon, who served as pallbearers.

Members of American Legion 203 and VFW Wm B. Wilson Post 666, of Beacon honored the late veteran. Grand Knight Kevin Allison, and members from Knights of Columbus Trinity Council 445 attended the service, as well as scouts from Scout Troop 41 of Beacon.

Escort assistance was provided by local

Patriot Guard Riders.

Olivo-Paz’s casket-remains were transported to the Gerald B.H. Solomon Saratoga National Cemetery.

Rev. Thawale said during the service, “Luis was a veteran. He had to sacrifice his life for the nation. For the people.”

The priest said Luis “is grateful because he knows there are people who love him.” Deacon Martin Mayeski assisted Rev. Thawale with the service.

“I’m so grateful too, for the community respect that I’ve gained. Whenever I call out for a funeral with no-family, everyone’s eagerness to show up for the deceased person, it’s amazing. Even the youth, from the Scouts and recently the local high school band, I receive a star trumpet player to sound Taps for military honors. It’s important to me, to teach the younger generation how to show up for the less fortunate.” Schuka remarked.

# Looking back and ahead on the COVID-19 pandemic

Two years ago, in March 2020, an invisible, harmful, and life-threatening enemy began to change our lives forever. The COVID-19 Pandemic continues to affect our physical and mental health, and economic well-being. No individual has escaped unaffected.

Before continuing, a heartfelt thanks for the past/ongoing efforts of all of our doctors, nurses, healthcare workers, first responders, teachers, supply chain workers, and countless others. Those guardian angels, their families, friends, our neighbors, are all heroes. May God bless them and continue to look over them. Since we continue to remain in your debt for your bravery and sacrifices, we will continue to reach out.

Since early February 2020, the Town of Wappinger government has been addressing relentlessly the many challenges that have disrupted our businesses, education, and personal lives. All Town staff and officials have been focused on doing the best that a local government can to mitigate the impact locally. From the outset of the Pandemic, I deemed all employees to be essential personnel, not only to help them earn a living but to continue to provide essential government services. Although, initially, we had to shut down physical access to Town Hall and our indoor facilities for 3 months, we did not let the emergency orders and mandates stop us.

Whether it was: operating continuous-ly our Town sewer and water systems; ensuring highway repair, maintenance, and snow removal; keeping open and maintaining our parks; and issuing vari-

ous permits for DIY projects, we remained on the job. We established and maintained advanced IT and telephone systems to conduct open and regular communications, not just with our residents, but with our County and State counterparts to address the constantly changing environment influenced by COVID-19. Throughout the Pandemic, we were among the first communities to establish and maintain a comprehensive and friendly set of protocols to protect our employees and residents until vaccinations and test kits would become readily available. Even then, we proactively distributed test kits, PPE, and information to residents in need.

A few of the many other significant actions that we undertook include that we:

- Created alternate means of electronic/written communications, including, at the Pandemic's worst, mail and document drop-off boxes outside of Town Hall;
- Kept open the Recycle Center to receive kitchen garbage initially;
- Monitored employee health (some of whom contacted Covid), and placed calls to our Senior Center members at least weekly;
- Initially, held Town Board meetings via Zoom, and then reopened live meetings once allowed by the NYS Governor (and earlier than most local municipal governments);
- Produced and posted various videos/graphic information for our residents;
- Expanded our Sheriff's Office Town Patrols;

g. Passed the earliest legislation allowing outdoor dining;

h. Reopened summer camp/other recreation programs earlier than most other municipalities, all-the-while maintaining the health and welfare of our participants (realizing the importance of physical and mental health of our residents); and

i. Kept taxes and fees lower than other neighboring municipalities.

But, we are far from done with our planning and initiatives. In the months ahead, we will sponsor more programs to assist with the physical/mental health and welfare of our residents. Also, other initiatives will enable us to continue to:

- Maintain conservative fiscal management while investing in our parks, recreation facilities, and our local environment;
- Maintain our diligence and planning for future natural disasters and possible pandemics;
- Invest in our infrastructure to provide more residents with quality, reliable water and sewer services;
- Study how future macro developments might impact our businesses, residential patterns, etc., so that we can be better prepared for many uncertainties and to reduce risk to our residents and businesses;

v. Work with the Wappingers Central School District and other organizations to provide increased opportunities for our Town's youth; and

vi. Focus on our Veterans, Seniors, and residents with special needs and those who are suffering from bullying, opioid abuse, and other diseases facing our community; to name a few.

## Early bond payoff to deliver \$1.55 million in taxpayer savings

Dutchess County Executive Marcus Molinaro has announced the county is again planning to do an early payoff of callable bonds to take advantage of more than \$1.5 million in savings, pending approval of the Dutchess County Legislature. The Department of Finance plans to pay off \$8,595,000 in debt principal on bonds originally issued in 2014, with payments scheduled through 2034. The early payoff will provide for \$1,552,142 in interest savings. The early retirement of debt is part of Dutchess County's smart, fiscally sound debt management strategy to save tax dollars and deliver those dollars back to residents.

Debt service is utilized to finance capital expenditures such as road and bridge projects, equipment acquisition, building construction and renovations, and other authorized activities. The County's operating budget includes annual payment of principal and interest through "debt service." As the county issues new debt, older debt is retired, helping to keep the county's annual operating expenditures stable. Dutchess County remains fiscally conservative with its use of debt - utilizing only 8.8% of the County's total constitutional debt limit. According to a 2020 New York State Comptroller Report, Dutchess County's debt per capita is 50 percent lower than the statewide average.

Standard & Poor's (S&P) Rating Services recently reaffirmed Dutchess County Government's AA+ bond rating - the highest S&P rating of any county in New York State - for the county's most recent debt issuance, which totaled \$70.2 million. This issuance finances numerous critical projects and investments approved by the County Legislature including highway and bridge improvements, Partnership for Manageable Growth, HVAC projects, Urban Trail project, the Dutchess County Justice & Transition Center and more. Although interest rates have been rising over the past few months, rates are still at historically low levels and the county was able to issue this debt at favorable rates ranging from 2.64 percent to 3.00 percent.

The county's bond rating was an important component in securing the low interest rates for the new bonds. S&P has consistently recognized Dutchess County's strong management, strong economy and strong budgetary practices and performances as key factors in its continued assignment of an AA+ bond rating. In its most recent rating, S&P highlighted the county's very strong general fund reserves and low overall net debt, noting "manageable additional capital needs."

As noted in the S&P report, the county's 2020 Year End Audited Financial Statements

demonstrate the county's strong fiscal foundation, including an unassigned fund balance of just over \$60 million, an increase of more than \$3 million from 2019. The county's Fund Balance Policy states the goal of maintaining an undesignated/general fund balance of 1-2 months of general fund operating expenditures in the general fund balance as a means of maintaining financial stability, which would range from \$38 to \$76 million. With the unassigned fund balance well within this target range, the County has been taking proactive steps to pay down or avoid indebtedness as well as provide property tax relief.

The 2022 County Budget included a historic \$20 million in cumulative tax relief, including the eighth consecutive property tax reduction as well as the elimination of the sales tax on clothing and footwear items costing less than \$110 per item. Additionally, over the past several months, the county has been paying off existing debt when allowable (or callable) and funding capital purchases utilizing fund balance rather than issuing additional debt.

Recent examples include:

- Annual vehicle purchase for 2021 totaling \$1.4 million was paid utilizing fund balance rather than a capital bond as has been past practice, saving \$50K in interest costs.

- \$1.25 million in various Dutchess Community College capital projects including plumbing and repairs paid utilizing fund balance rather than a capital bond, resulting in \$388K interest savings.

- Early payoff of \$4.9 million in remaining principal from bonds issued in 2012-2013, resulting in \$470K interest savings and \$4.9 million in overall debt reduction including \$1 million debt service reduction for 2022.

- Recently approved Emergency Response vehicle purchases totaling \$2.1 million to be funded from fund balance rather than capital bond financing, saving \$476K in interest costs.

- Recently approved countywide Radio Communication System Project to be funded utilizing fund balance (as well as American Rescue Plan and New York State SICG grant funding) rather than capital bond financing, saving \$907K in interest costs.

- Bus facility improvements and building roof projects paid utilizing fund balance rather than a capital bond - saving \$636K in interest costs.

The resolution authorizing the early payoff was reviewed at the County Legislature's Budget, Finance and Personnel Committee on March 10. The full County Legislature was expected to vote to authorize the payoff at its March 14 board meeting.

# Women veterans have unique set of challenges

March is Women’s History Month, and it’s a wonderful opportunity to recognize the women among us who have served in the military, and continue to serve their communities in all sorts of ways. All veterans face challenges, but sometimes we forget our women veterans can face even more obstacles – with health care, with employment, and with simply being seen as a veteran.

I’m lucky to be friends with two amazing women veterans who work with MHA Dutchess Veterans Programs, Alyssa and Victoria, and recently we talked on the radio about the unique challenges and triumphs that women vets face every day. Alyssa is an Army veteran and a USMA graduate, while Victoria is a Navy veteran who was stationed out of San Diego during her service. Through their work helping other veterans at MHA as well as their own experiences, both Alyssa and Victoria have first-hand knowledge of many of these unique challenges.

“Sometimes we have to remind people we’re veterans, too,” Victoria shared with me. She told me about an experience she had at the VA Hospital after her discharge from the Navy. “The medical staff at the VA were asking me who I was with, or if I was there with my husband at the hospital,” she said, shaking her head. “And I had to tell them, I am the veteran. I’m not here with anyone. I’m the veteran who is here for health care.”

As a proud graduate of West Point, which did not allow women to participate until 1976, Alyssa also knows the obstacles sometimes facing our women in uniform, both during and after their service.

“As veterans, all we want is to be treated equally,” she said. “At MHA Dutchess

Veterans Programs, when Victoria and I meet a woman vet for the first time, we want them to know we understand their struggles, because we’ve had the same struggles transitioning into civilian life, too.”

MHA Dutchess hosts a regular roundtable session for veterans to talk with other veterans, but Alyssa also mentioned they are trying to add a separate session for women vets only. We’ve talked about this before in previous Dispatches: the face of our veteran population is certainly changing over time. And yet, when we think of a veteran, often we still picture an older, white male with perhaps a scratchy beard or an anchor tattoo on his arm. But almost 1 out of 8 combat veterans returning from the Iraq and Afghanistan conflicts were women, and furthermore, 1 out of 4 of those veterans were people of color. Yes, the face of our brave veterans is changing, and we should ensure all our veterans are honored and recognized in the same way. They deserve nothing less!

We all know sometimes our women veterans may not get the recognition they deserve for their service, even more so than their male counterparts. So this month, let’s take a moment or two to thank the women vets in our lives, as part of Women’s History Month.

Thank you to Alyssa and Victoria from MHA Dutchess Veterans Programs for talking with me on the radio recently. And thank you, for listening! See you next time!

## National Drug & Alcohol Facts Week set March 21-27

Ahead of National Drug & Alcohol Facts Week, March 21-27, the Council on Addiction Prevention & Education (CAPE) is offering Dutchess County parents and guardians and their children ages 12 to 19 access to Teen Intervene, a program dedicated to helping teenagers in the early stages of alcohol and drug misuse. The free program is part of a state-wide initiative through New York’s Office of Addiction Services and Supports (OASAS).

According to Mental Health America, 4% of adolescents, nationally, reported having a substance use disorder in the last year, 1.64% noted that they are abusing alcohol and 3.16% admitted to using illegal substances. Specifically, New York reports 3.87%, or 52,000, of adolescents

are currently struggling with a substance use disorder. Through Teen Intervene, an evidence-based program, teens and their parents are provided education, support and motivation through a series of two to four sessions that are designed to help reduce, and eventually eliminate, the use of alcohol and/or other drugs and other risky behaviors.

“We know how important it is to meet teens where they are and recognize that many may not see their use as an emerging problem or be aware that they need to change their behavior,” said CAPE’s Agency Director, Crissy Groenewegen. “That’s exactly what this program was designed for – welcoming any teenager who has experienced mild to moderate problems with substance use into a calm,

confidential educational environment.”

Parents and guardians will also have the option to attend a session with their teen to further their own education and learn how they can better support their loved one. In fact, CAPE has expanded the reach of this free program even more by offering both in-person – at a host of locations across Dutchess County, from public and private schools and residential treatment facilities to community centers – and virtual sessions in both English and Spanish.

# Sheriff's Office investigating increasing phone scams

The Dutchess County Sheriff's Office would like to take this opportunity to warn the residents of Dutchess County and surrounding areas about scams that once again seem to be on the rise.

Scams are ways in which criminals will attempt to get money from people by contacting them and making up elaborate stories. In some cases the perpetrators have tried, sometimes successfully, to use the victim's emotions about a loved one in trouble to get money. It's common for the perpetrators of these scams to try to get money by telling people that one of their relatives has been seriously hurt or is in jail, and that they need money right away. In many cases they will pose as a law enforcement official or another relative to try and convince the victim that it's legitimate.

The latest scam involves the perpetrators posing as representatives of law enforcement. The Sheriff's Office received two calls about this scam on March 9, and in both cases the perpetrators identified themselves as "Sgt. Jason Mark" and left voicemails instructing the victims to call them back right away about an urgent matter. In both cases the call recipients recognized it as a scam and contact the Sheriff's Office immediately.

The Sheriff's Office would like to offer the following tips to help people avoid these scams:

- Legitimate law enforcement would not attempt to satisfy a warrant or make promises to avoid prosecution by soliciting money.
- If you receive an email about an order you didn't place or asking you to send money call the company using a legitimate number. DO NOT follow the instructions in the email, click on any links in the email, or call the number provided in the email.
- If someone asks you to purchase merchandise, transfer money, provide bank information, or enter a code given to you by them use caution as it is likely a scam.
- Do not meet up with someone that you don't know; if you're asked to do this it is surely a scam, and it is very dangerous as well.
- If you're contacted by someone you don't know asking for money, for any reason, that's a signal that it's most likely a

scam.

• If someone calls you and tells you that a relative has been hurt or is in jail, confirm it first before sending any money. Call other relatives or a legitimate law enforcement agency for confirmation before any money is sent. If they're posing as a relative, try and contact that relative for confirmation.

• Sending money overseas is especially risky; use extreme caution.

• Ask the person for their call back number and ask to speak to their supervisor to confirm the info; if it's a scam they will most likely hang up at this point and the number they give you will be bogus.

• If the person is telling you that a loved one is in the hospital or jail, find out which one and contact the institution yourself to confirm.

• If a loved one has recently passed away be wary; in some cases perpetrators have even preyed on victims by searching through the obituaries and calling surviving loved ones. If you get calls from people you don't know soon after someone passes away, be careful and confirm it before you send any money.

• In some cases someone will call and tell the victim that they've won money, but to "process the claim" they need to first send money. Beware this is most definitely a scam and don't send any money - you should never have to pay money to claim a prize. If it seems too good to be true, it most likely is.

• If there's any doubt about a phone call or email received, contact the Sheriff's Office before sending any money.

• Scams tend to increase during the holiday season, be especially alert for them during those times.

It is very important to not send any money to anyone that you don't know until you've confirmed the situation through an independent source and feel comfortable with it. If it's a scam once the money is sent it's very difficult, and most times impossible, to get it back. If anyone thinks they may have been the victim of a scam they are encouraged to contact the Sheriff's Office at 845-486-3800 or via the tipline at 845-605-CLUE or dcsotips@gmail.com.

# Investigation continues in fatal LaGrange crash

The State Police continue to investigate a fatal crash involving a State Police patrol vehicle and an Arlington School District bus, which occurred on March 8 on Route 55 and South Cross in the Town of LaGrange.

Two adult students were on the bus at the time of the crash and were transported to MidHudson Regional Hospital with non-life-threatening injuries. An adult aide on the bus was pronounced deceased on scene by responding LaGrange Fire Department paramedics. The bus driver and trooper were transported to local area hospitals with non-life-threatening injuries.

The initial investigation determined that the State Police patrol vehicle, operated by Trooper Christopher Batista, was eastbound on State Route 55 in a non-emergency status. The Arlington School District bus was northbound on South Cross Road and failed to stop at the stop sign while attempting to enter State Route 55. The patrol vehicle and bus collided, causing the bus to then strike a utility pole.

The investigation determined that the bus aid, Robin P. Alvarez, age 59, of East Fishkill, was not wearing a seat belt.

This investigation remains ongoing.

Dutchess County police agencies will participate in a special enforcement effort to crack down on impaired driving during the St. Patrick's Day holiday. The statewide STOP-DWI crackdown efforts will start on Wednesday, March 16, and will end on Sunday, March 20.

Transportation's National Highway Traffic Safety Administration, 10,142 people were killed in drunk-driving crashes nationwide in 2019. On average, more than 10,000 people were killed each year from 2015 to 2019, equating to one person killed in a drunk-driving crash every 52 minutes in 2019.

## Laerdal leader who lives with heart disease to chair 2022 Heart Challenge in the Hudson Valley

Donna Kosack's family and her own health history have made her a strong advocate for educating people about heart disease.

"How many people don't know they have heart disease, or don't know the signs and symptoms?" Kosack, Systems Adoption Manager at Laerdal Medical, asked. "I'm chairing the 2022 Heart Challenge to help raise awareness."

The 2022 Dutchess-Ulster Heart Walk is part of the Heart Challenge, and is set for Saturday, April 30, at The Walkway Over the Hudson State Historic Park. To ensure safety for all participants, the Walk will let people begin walking any time they like between 9 and 11 a.m.

Kosack always knew she needed to be diligent about her heart health. When she was in her 20s, her uncle, then in his 40s, had his first heart attack. Her father and grandfather had also had heart disease. But after her mother was diagnosed with cancer for the second time, Kosack was sitting on her couch and felt pressure in her chest. At the physical she had scheduled for the next day, doctors detected a heart murmur and sent her to a cardiologist.

Kosack was surprised to learn she had a bicuspid aortic valve – a congenital heart defect which means that her heart valve has two flaps instead of the customary three – which has created an aortic aneurysm.

Kosack immediately had her two daughters

and son checked to make sure this isn't something they inherited. They don't have it.

"I'm monitored closely for the aortic aneurysm," Kosack said. "If it gets too big, doctors will operate on it, and replace my valve at the same time."

Kosack credits American Heart Association events with making her more aware of heart disease. Laerdal is a longtime sponsor of the Dutchess-Ulster Heart Walk and Kosack has volunteered and participated in AHA events in the 14 years she has worked at Laerdal. She was also a member of the BetterU program in the Hudson Valley, a 12-week heart-health improvement program for women that is celebrated at the Go Red for Women Luncheon.

"I find takeaways at Heart Association events each year," she said, "and I try to educate myself and others about heart issues wherever I can."

Kosack has also followed the Heart Association's health advice.

"We all have a heart, and we need to protect it," Kosack said. "I avoid eating anything that could build up calcium in my arteries, abstain from smoking, practice good dental hygiene and drink lots of water. Exercise is also so important, yet challenging. I do aim for 8,000 to 10,000 steps a day, and have set a goal this year to bike 77 miles to Manhattan starting at the Dutchess Rail Trail.

"My message to the community is, look

out for your health and take care of each other. We all need to get back outside and what better way than the Heart Walk? By

being part of this event, you are joining in heart health and continuing to improve the lives of the people you love.

"As a community, let's also be there to help the continued efforts of the AHA by investing. By investing time and money we continue the mission of the AHA, which is helping many people lead better and healthier lives. The Heart Association provides educational information, teaches CPR and of course, invests in research."

"It's great to be having an in-person event again, and Donna is a terrific leader for this," said Sunny Intwala, M.D., cardiologist at Nuvance Health and president of the Dutchess-Ulster Board of Directors for the American Heart Association. "Her perspective as a survivor reminds us that it can be surprising who suffers from heart disease. Laerdal is a longtime supporter, and Donna has been a longtime participant. She is an enthusiastic and dedicated leader. We're grateful that she is chairing the campaign."

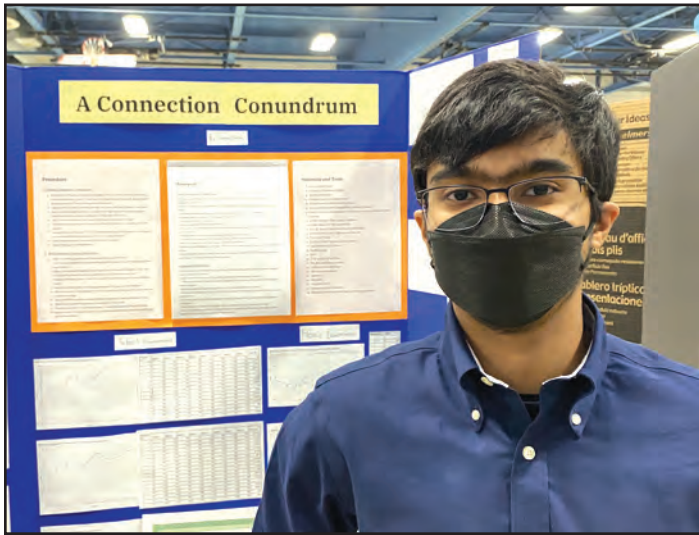
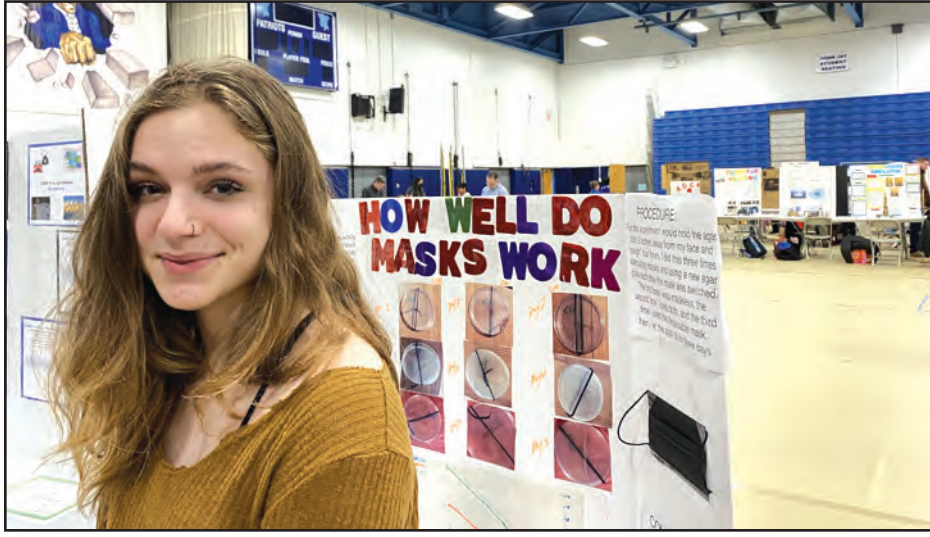

The Commission on Human Rights is composed of 14 volunteer members and an Executive Director/ Chair employed by the County. The Commission, which meets monthly, works to defend human rights, bridge differences, and embrace diversity in Dutchess County. Between meetings, members participate in various work groups to help carry out this mission. Volunteer applicants must be at least 18 years old and must be prepared to spend approximately five to 10 hours a month on the Commission's work. There will be four membership vacancies effective September 2022 as current members' terms expire. New Commission members terms will begin on October 1st, and are three year appointments.

All candidates will participate in an interview process with the Commission's Nominating Work Group. The Work Group then reports to the full Commission, and the Commission makes its recommendations to the County Executive and Chair of the County Legislature. All appointments are subject to confirmation by the Dutchess County Legislature.

## Poughkeepsie resident reappointed poet laureate for Dutchess County

*Historical society to host 'Hidden Treasures of the Hudson Valley' talk*

Dutchess County Executive Marc Molinaro announced he has reappointed Poughkeepsie resident Dr. Lucia Cherciu as the County's Poet Laureate for 2022. Dr. Cherciu will continue to bring poetry to the community through a series of reading events throughout the year.

Molinaro said, "The bold creativity of the artists within our Dutchess County arts community have helped to bolster our spirits, strengthen our relationships, and build us all up during some of the most trying times we've been through. I am confident, as we find our way back to normalcy, the arts and our artists will continue to keep us connected and improve our quality of life. We are proud to continue our commitment to the arts and look forward to Dr. Cherciu's continued contributions as our 2022 Poet Laureate."

Dr. Cherciu was born in Romania and came to the United States in 1995. She received her Ph.D. in English from Indiana University of Pennsylvania in 2000 with a dissertation on women and laughter, titled "Ludicrous 'Scribbling Women': The Politics of Laughter and Nineteenth-Century American Women Writers." She is a Professor of English at SUNY/Dutchess Community College, where she has been working for twenty years. She enjoys working with her students and in spring she usually conducts a Service Learning Project at Morse

Elementary School.

"These are difficult times, when people around the world understand how important it is to work together, support one another, and use writing in order to communicate, show compassion, and help in the process of healing." Dr. Cherciu said, "The crisis in Ukraine has demonstrated to us how words can be used to show solidarity and work towards making peace. Poetry, story-telling, and all the arts can contribute to changing the world, making us more empathetic and kind, so we can reach out to our neighbors and help them out. We should all work together to ensure that all schools have access to resources in order to teach Visual Arts, Music, Poetry, and use creativity in the spirit of Diversity, Equity, and Inclusion."

Dr. Cherciu writes both in English and Romanian and is the author of five books of poetry: Train Ride to Bucharest (Sheep Meadow Press, 2017), which received the Eugene Paul Nassar Poetry Prize, Edible Flowers (Main Street Rag, 2016), Lalele din Paradis / Tulips in Paradise (Editura Eikon, 2017), Altoiul Răsului / Grafted Laughter (Editura Brumar, 2010), and Lepadarea de Limba / The Abandonment of Language (Editura Vinea, 2009). Dr. Cherciu's poetry was nominated three times for a Pushcart Prize, twice for Best of the Net, and her work has appeared in numerous publications.

# Did you know?

Fun facts about Saint Patrick and the traditions surrounding his feast day, March 17.

Top o' the mornin' to ya! It's once again time to get your Irish on, no matter if you're reading this after March 17. With it falling on a Thursday this year, we're given the perfect excuse to carry it through two weekends, one before and one aft, so put on the kettle for some tea as we learn some Saint Patrick's Day facts you may not know. Now let's crack on.

They say everyone is Irish on Saint Patrick's Day, and it's true that people the world over celebrate it, but did you know that this adage pertains to the saint himself? Born in the 5th century to Roman parents in either Wales or Scotland, his name was originally Maewyn Succat. He was kidnapped and made a slave in Ireland. He escaped and returned home where he had a life-changing vision to return to Ireland to spread the message of Christianity.

Which brings us, believe it or not, to the shamrock, Ireland's unofficial national plant and national symbol. The three-leaved green plant is thought to be white clover and it's said that Saint Patrick used the shamrock to visually explain the concept of the Holy Trinity to nonbelievers he wished to convert. The unrelated four-leaf clover has no connection to the saint but is considered lucky because finding one is so rare, signifying the luck o' the Irish. Today many pin shamrocks to lapels and hats in remembrance of his teachings. Remember, this IS a day that celebrates a saint.

This is in part what's meant by "the wearin' o' the green." Every Saint Patrick's Day, a member of the British royal family presents Irish Guards with shamrocks for their headgear, a tradition started by Queen Victoria in 1900 to acknowledge and support Irish volunteer soldiers who had helped the British military in the Boer War. Prior to that the British forbade the Irish from wearing green because it symbolized to them their national pride and independence. Knowing this, the United Irishmen made green their official color, already an open symbol of Irish identity, as they planned to rebel against the British who had even gone so far as to hang anyone for the Wearing of the Green. Wow.

But on a lighter note, another theory is that wearing green makes you invisible to leprechauns. Not so sure about that one, but interestingly, the official color of Saint Patrick himself wasn't green at all; it was light sky blue. Because of the Irish Independence movement in the 18th century – and the saint's shamrocks – green became the color representing the Catholics of Ireland and, on a wider scale, the Emerald Isle herself.

But what about the snakes, you may ask? It's a widely-held belief that Saint Patrick drove the snakes from Ireland, hence the fact there are none to be found there to this day. Science has another theory. Fossil records show no evidence that

snakes ever lived there, which makes sense. It's an island too cold for reptiles and too protected by the surrounding sea to allow any to find their way, let alone land, there. Most likely the snakes in this case are metaphorical.

The obvious religious connections to the holiday may have you curious how it evolved into such a grand occasion to drink. March 17 didn't become a national holiday until 1903 and pubs at time were not allowed to open, both because it was a day meant to honor a revered saint and because it fell during Lent, a time when fasting and sacrifice were required by the Catholic church. Pubs in Ireland were allowed to open in 1973, but that's not to say people went without for all that time. For many it was a considered a welcome break from fasting when they could enjoy alcohol, sweets and meat. America's traditions were not nearly as strict and clearly still aren't for most. Today millions of pints of Guinness are consumed and it's the biggest day for bars in America.

Because it's also a day of national pride, parades are another huge part of the celebration. The first parade held in Ireland wasn't until 1903 in Waterford; the first in Dublin was 1931. New York City's Saint Patrick's Day Parade is one of the largest and oldest in the world and the largest in America, with over 150,000 participants, 2 million attending and over 5 hours long. It has taken place since the 1762 and still consists of only marchers (and bagpipers): no floats, cars or other vehicles. The only time it did not go on? 2020 and 2021, due to the pandemic.

And with all that drinking and marching, you're sure to need to get some food in you. Perhaps some corned beef? But

why is it called that when there's no corn at all? The large kernel-like grains of salt used to prepare it were called corns. Corned beef became more popular among the Irish when they immigrated to America where beef was much more plentiful than it had been back home. Though plentiful, though, many immigrants were not rollin' in the green and so cheaper, less tender cuts of beef were used, like brisket, which they made tender by soaking for a long time in brine with spices to break down the connective tissue and add flavor. Then it would be slow cooked until fork tender, served with cabbage, carrots and potatoes and a classic was born.

In researching Saint Patrick's Day I discovered a lot I didn't know and enjoyed the journey. And, yes, I will be celebrating with parades and corned beef, whiskey and the black stuff. But I'll be doing so with people I love, some who are Irish and some, like myself, who only are for one day a year, and I thank my lucky stars that this festive holiday gives each and every one of us a chance to share the rich treasure that is Ireland. Slainte! (Raise a glass!)

# Flower bulbs to plant in spring

### A primer on which bulbs to plant, and when to plant them

A sticker on the box says “dig, drop, done.” Somebody is trying to convince you that planting flowers from bulbs is easy.

They're right. Hundreds of beautiful varieties of flowers and even some vegetables can be started by digging and dropping the bulbs, corms, tubers or rhizomes directly into the garden. In a few days, the frost will be out of the ground and the soil should be dry enough to get started.

We're not talking about tulips, hyacinths or daffodils, the traditional Dutch bulbs that have to be planted in the fall to bloom the following spring. (You already planted them, right?) Here are some of the ones that can be set out now:

- Lilies – Asiatic lilies, with their big upward-facing blossoms, are hardy perennials in the Hudson Valley, as are Easter lilies (*L. longiflorum*), the fragrant “Stargazer” and tiger lilies. All require at least partial sun and well drained soil.

- Daylilies – Not really lilies, they are in the genus *Hemerocallis* (a Latin word meaning “deer food”). So hardy they are almost impossible to kill. The tawny orange day lilies lining the roadways in June are escapees from long-ago colonial era gardens. Amateur breeders have created thousands of varieties, in a rainbow of colors. There's even one called “Becky Adams,” not actually named after my daughter, but one was gifted to her by members of the Hudson Valley Iris and Daylily Society.

- Iris – The old-fashioned German or Bearded Iris was a garden staple a hundred years ago, and the original rhizomes (thick roots) are still blooming in late May if they weren't disturbed. The Blue Flag Iris is a pretty native wetland flower, but its cousin the Yellow Iris (*I. pseudacorus*) is a prohibitively invasive species.

- Dahlias – Warm weather dahlias grow from tubers (thick underground stems, not true bulbs). Plant after the soil has warmed in May. Passionate gardeners have created thousands of dahlia varieties, some with blossoms as big as dinner plates. The tubers will not survive our Hudson Valley winters, so dig them up in October and store them in a cool, dry place, maybe packed in dry peat moss. Bear Creek Farm in Stanfordsville is world-renowned for their dahlia flowers, tubers and workshops. They open on March 18.

- Begonias – Another warm weather tuber that needs to be stored over the winter. Unlike most bulb plants, begonias flower all

summer, and will tolerate shade. To get a jump on the growing season, you might want to start the tuber indoors in a pot, since it needs very warm weather to thrive in the garden.

- Canna – For a lush, tropical garden, you can't beat Cannas. They grow fast, up to seven feet tall, depending on the species, and flower for a few weeks in summer on successive blossoms. The rhizomes will not survive our winters. Dig them up and store in a cool, dry place until you replant them the following May. Add fertilizer, as the top heavy foliage sucks a lot of nutrients from the soil.

- Crocosmia – A stunning addition to any garden. The fiery “Lucifer” is winter-hardy in the Hudson Valley. Plant the corms (they look like bulbs) in May. Leave the foliage intact after blooms fade so the plant can produce a new corm for next year.

- Elephant Ears – Colocasia, or taro, is a nutritious food in tropical parts of the world. I wouldn't call it delicious. The taro I ate (with my fingers) in Zambia was bland and a bit slimy. Grown for its foliage, Elephant Ears is a gigantic, Instagram-worthy tangle of shiny green leaves. The tuber, which can be the size of a coconut, is planted in sun or shade and must be lifted in the fall for winter storage.

- Vegetables from bulbs, corms or rhizomes or tubers – Potatoes, Jerusalem artichokes, asparagus, garlic, onions, and rhubarb, even Giant Brazilian Rhubarb, to name a few.

- Gladiolas – I can give Luigi Coppola a run for his money with a humorous family anecdote: A couple of days after I met my life partner Sue, I was down in the corn field – we rented land on Overlook Road – with my Dad and a few other workers. We were picking sweet corn on a Sunday morning. In between the rows of corn, gladiolas were blooming. We usually picked a few dozen “glads” every day and tossed them on top of the bushels of corn to bring back to the farm stand to sell for a dollar per stem, which was pretty good money in 1974.

Anyway, I had told Sue to drive down into the field around noontime. The plan was to introduce her to my dad and then ask for the afternoon off so we could go to the German Alps Festival at Hunter Mountain. Sue came speeding down the roadway in her green Volkswagen beetle, trailing a cloud of dust.

Me: “Dad, I'd like you to meet a friend of mine, Sue Gotthardt.”

Dad: “Nice to meet you. Here's a pair of

clippers. Go pick those gladiolas.” She married me anyway.

# Prog-rock pioneers Nektar to play Daryl's House Club March 23

For more than 50 years, Nektar has taken legions of fans on audio-visual journeys to far reaches of the universe and the depths of the ocean with their immersive blend of sight and sound. These progressive-rock pioneers have been champing at the bit to get back on the road, and they'll be at Daryl's House Club on Wednesday, March 23, one of the stops on their "Vinyl Sides Live" tour.

Back when vinyl was king, Nektar was renowned for songs the length of an album side, hence the name of the tour. Audiences will be treated to entire album sides from some of Nektar's epic recordings – including "A Tab in the Ocean," "Remember the Future" and "Recycled," as well as "The Other Side." Rounding out the shows will be expanded offerings from other albums; unfinished tunes from 1978 that the band has rediscovered; as well as brand new compositions the band has created during their weekly online and in person get-togethers.

Nektar has captured the imagination and admiration of listeners the world over with their "Music and Light Theatre," multi-media concerts, melding a jam-band vibe with superb musicality and a visual cornucopia that perfectly complements the performance.

Formed in Germany in 1969 by British expats, Nektar soaked up the musical freedom they found in their new home, favoring extended compositions and concept albums over the constraints of pop. They were among the progenitors of the progressive rock movement of the 1970s as well as the jam-band scene that arose in the late 1990s. Their sound traveled well to the States, where they enjoyed Top 40 success with "A Tab in the Ocean" (1972) and "Remember the Future" (1973). Nearly 20 albums and a half-century later, the band's artistic and personal charisma has earned them masses of devoted fans.

Currently, Nektar features three of the original members – Derek 'Mo' Moore (bass guitar, vocals), Ron Howden (drums, percussion, vocals) and Mick Brockett (visual environment). Ryché Chlanda (guitar, vocals) and Randy Dembo (bass guitar, bass pedals, 12-string guitar, vocals) are
